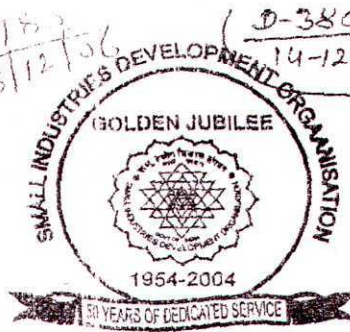

Sir,

This has reference to your letter No.TCTI/17499/06 dated 20.11.2006 on the above mentioned subject. The clarifications sought are explained as under:

- EM
- (1) The units which were in the category of non-SSI and are now covered under the category of small enterprises as a result of coming into force of MSMED Act, 2006, may file Entrepreneurs Memoranda(EM) and shall be treated as small enterprises.
 - (2) In case of additional investment, increasing capacity etc., the earlier figures existing in the Memoranda filed should be updated by enclosing a separate sheet, clearly showing the date from which the enhancement has taken place.
 - (3) Clause (a) of the proviso of sub-section (1) of section 8 of MSMED Act, 2006 stipulates that existing units which have obtained registration certificate may, at its discretion, file the Memorandum within 180 days w.e.f. 2 October 2006.
 - (4) All the SSSBE units in the service sector can be treated as enterprises rendering service and these can file Memorandum as service enterprises.

2. In addition, we may like to inform that the numbering of the EM may start from 00001 for each category of enterprise followed by (out of the box) micro or small or medium which should again be followed by part I or part II as the case may be.
