Reg: Allotment of vehicle to Br. Offices for making campaign a success.

This year two special campaigns for contacting promoters/guarantors of deficit cases/decreetal cases/written-off cases and pursuing for registering their cases for settlement of account have been scheduled.

The first campaign has already been organised from 24th to 29th April, 2006 and next campaign is scheduled to be held from 22nd May to 27th May, 2006.

In the first campaign, vehicles of BOs /ROs were allotted to field offices for two days to each branch. Maximum budget for hiring the vehicle per day is restricted upto Rs 800/-.


**Justification Report from BOs:**

In order to justify hiring of the vehicle, BOs are required to send report to HO by 31.5.06 giving details of number of units where properties have been

identified, recovery made, number of promoters/guarantors contacted, cases registered for settlement and likely cases to be registered in June, 2006.

The said information regarding justification for hiring the vehicle shall be sent by BOs in the prescribed format enclosed with the earlier Circular No. ARRC.127 dated 5.4.2006 regarding allotment of vehicle daily to DGM(ARRC).
