CIRCULAR

This has reference to the above referred letter regarding clarification about the procedure of SSI registration. The procedure of SSI registration has been done away with the implementation of MSMED Act, 2006 (i.e. w.e.f. 2 October 2006). An entirely new process of filing of EM, as contained in Section 3 of MSMED Act, 2006 has since been implemented.

As mentioned in the Section 8 of the said Act " Any person who, before the commencement of this Act, established- a) a small scale industry and obtained a registration certificate, may at his discretion can file the memorandum. In short it has nothing to do with the erstwhile system of SSI registration. There is no requirement for surrendering the earlier permanent registration certificates or canceling it prior to filing of EM Part II. The fact is that any enterprise, whether earlier registered with DIC, or not, may (repeat, 'may' i.e. optional) file EM Part II if it is a micro or a small enterprise, whether it is a manufacturing or a service enterprise. Similarly, it is optional for a medium service enterprise to file an EM.

It is once again reiterated that the erstwhile SSI registration has been done away with and has no linkage with filing of EM. It is guided that the enterprises may kindly be encouraged/motivated for filing of EMs, so that the government obtains a strong data base that could facilitate policy formulation. While doing the census, the working units registered prior to 2.10.2006, can be motivated to file EM. A copy of the above-referred letter is enclosed for information and proper action. Please communicate the procedure to all Associations within your jurisdiction.

You may give wide publicity in Newspapers for awareness to the entrepreneurs
