U/S 31(1)(aa) and Section 32-B of
the SFCs Act, 1951.


The Corporation has been filing suits/applications for recovery of dues from the original borrower and/or Mortgagor-Guarantors under the provisions of Section 31(1)(aa) and 32-B of SFCs Act, 1951. In most of the cases recovery is for the deficit amount and/or the advance made from the guarantors may be the Mortgagor-Guarantor or third party guarantor.

We desire detail about the recovery effected by the branches under the provisions of Section 31(1)(aa) and 32-B of the Act since for last three years. Only 15 branches have informed that they had recovered Rs. 74.96 lacs under the provisions of Section 31(1)(aa) and the 14 branches have recovered a sum of Rs. 38.83 lacs under the provisions of Section 32-B. Some of the branches have reported nil recovery.

With a view to ascertain and identify branches which are taking effective step and the branches which are not taking effective step, the detail in the enclosed formats marked as Annexure-A & B is required.

All branches are advised to furnish required information in the enclosed format as on 1.4.2002 within 15 days from the date of this Circular. In future this information is to be sent on quarterly basis to the ED, RFC within 15 days from the close of quarter.
