7. The steel furniture items shall be supplied within one month our as mentioned in supply order from the placing of the order failing which penalty as per GF& AR shall be recovered. In –unavoidable circumstances like bulk orders, problems of inspection agency and long distances etc. a grace period upto 15 days shall be allowed.
8. 100% amount of Proforma Invoice deposit in advance by Demand Draft / Banker Cheque or online payment in the favour “ The Rajasthan Small Industries Corporation Ltd.” Payable at Jaipur is essential condition for arranging supplies. DD charges shall be borne by consignee department (purchasing department).Please send DD/Bankers cheque or information of online payment before 25-9-2014 positively.
